1. Limited Register Acknowledgment

The Purchaser acknowledges and agrees that:

1. The dog purchased from Activ Goldens is registered with Dogs Queensland / ANKC on the **Limited Register**.
2. A dog registered on the Limited Register:
 - Is not eligible to be exhibited at conformation shows.
 - Cannot have its progeny registered with the ANKC.
3. The dog is sold strictly as a companion animal.

2. Mandatory Desexing Requirement

The Purchaser agrees that:

- The dog must be desexed at 18 months of age, unless Activ Goldens provides prior written approval not to do so.
 - The dog must not be desexed prior to 18 months unless medically required and supported by written veterinary advice.
 - Written confirmation from a registered veterinarian must be provided to Activ Goldens within 14 days of the desexing procedure.
 - Failure to desex the dog by 18 months (unless written approval has been granted by Activ Goldens) constitutes a breach of this Agreement.

3. Absolute Prohibition on Breeding

The Purchaser agrees that the dog:

- Must not be bred from under any circumstances.
- Must not be used for mating, stud services, artificial insemination, semen collection, embryo transfer, or any reproductive purpose.
- Must not be used in any third-party breeding, leasing, or co-ownership breeding arrangement.

This prohibition applies regardless of ANKC registration status or any future change in registration.

4. Transfer or Rehoming

If the Purchaser sells, gifts, transfers, or otherwise parts with possession of the dog:

- The Purchaser must notify Activ Goldens in writing prior to transfer.
 - The Purchaser must ensure the dog is desexed prior to rehoming.
 - The original Purchaser remains fully liable under this Agreement.

5. Liquidated Damages

The Purchaser acknowledges that Activ Goldens has invested substantial financial resources in imported UK working bloodlines, genetic testing, health testing, and brand development.

If the Purchaser, or **any subsequent owner** deriving title from the Purchaser, breeds from the dog:

- The Purchaser agrees to pay **\$50,000 AUD** to Activ Goldens as liquidated damages.
 - This amount represents a genuine pre-estimate of loss, including loss of breeding exclusivity, genetic value, and reputational harm.
 - Payment is due within 14 days of written demand.
